

Cycling NSW Membership for Races

This document provides you with membership of Cycling NSW (**CNSW**) up to and including 31 December 2020. It is an important document and you should read it carefully before signing. If you sign it, then for the period between signing and 31 December 2020 you will be a member of CNSW for the purposes of competing in CNSW sanctioned events and races conducted by cycling clubs who are members of CNSW. This membership is provided on the terms set out below.

You acknowledge that events and races are inherently dangerous and may involve risk. You recognise and understand that there are risks specifically associated with events and races which include (but are not limited to) collisions and contact with other participants and road users, riding on roads of varying quality and which might only be partially closed to traffic, the remoteness of the areas in which an event or race takes place, sudden and unexpected changes in weather, physical exertion and difficulties in evacuation if you become injured or disabled. You acknowledge that accidents can and often do happen which may result in property damage, injury or death. Before undertaking any event or race, you acknowledge that you are aware of all of the risks involved, including those risks associated with any health condition you may have.

By signing this form, you acknowledge, agree, and understand that participation in events and races may involve risk and you agree and undertake any such risk voluntarily. You acknowledge that the assumption of risk and warning above constitutes a "risk warning" in accordance with relevant legislation, including but not limited to the Civil Liability Act 2002 (NSW). You also declare that you are medically and physically fit and able to participate in events and races and before doing so will disclose in writing any pre-existing medical or other condition that may affect the risk that you or another person will suffer injury, loss, damage or death. You agree to report any accidents, injuries, loss or damage before you leave any event or race.

You release CNSW from all claims, actions, demands, proceedings, damage, liability, cost or expense including (but not limited to) negligence. This release does not include a claim against CNSW by any person expressly entitled to make a claim under the insurance benefitting CNSW at that time or under any right expressly provided for under the constitution or by-laws of CNSW.

You acknowledge that CNSW has the benefit of certain insurances previously effected by Cycling Australia and that this insurance does not provide full indemnity for loss, damage, injury or death and does not provide cover for any damage to your bike or any other property. The insurance also does not cover damage that you may cause to the bike of another participant and that your own insurance arrangements are ultimately your own responsibility.

You agree to comply with the CNSW constitution and by-laws as well as complying with all laws and the requirements of all authorities in relation to the event or race. You also agree to comply with the requirements of the UCI and its Confederations and all relevant anti-doping policies which apply to CNSW and its members. You acknowledge that CNSW and anyone authorised by it may search bags, possessions and clothing to provide samples for testing. You consent to the use of photos and electronic images being taken of you in connection with the event or race and agree that such photos and images are owned by CNSW and may be used by them without any further consent being required.

You agree that these terms of your membership are governed by the laws of NSW and you submit to the jurisdiction of the courts of NSW.
